OUR PRIVACY POLICY

DIGIFISH GROUP PTY LTD has endeavoured to write a privacy Policy that uses plain language, avoiding technical or legal jargon, and that describes how we collect personal information about Consumers, what information we collect, the purposes for which Personal Information is collected and how it is disclosed.

ABOUT US

DIGIFISH GROUP PTY LTD (DIGIFISH) does not collect Personal Information directly from you the Consumer. DIGIFISH GROUP PTY LTD contracts with Contributors to utilise their Consumer data assets where you the Consumer have allowed your information to be passed to third party businesses like DIGIFISH GROUP PTY LTD.

UNDERSTANDING OUR CONTRIBUTORS

Our Contributors of three types of businesses, these include online mobile device driven location data collectors, offline opt-in lead generation data collectors and offline attribute data at address and person level collectors.

In reference to our Contributors when we refer to DIGIFISH GROUP PTY LTD collection practices below we are referring to our Contributors collectively.

WHAT WE REQUIRE FROM OUR CONTRIBUTORS

DIGIFISH GROUP PTY LTD contracts with Contributors such that they warrant:

- The Consumer records are collected in compliance with the Australian Privacy Act 1988.
- The Consumer consented / opted-in such that their details can be utilised to fulfil DIGIFISH Use Cases.
- The Consumer consented / opted-in such that their details can be provided to third party organisations downstream like DIGIFISH.
- The Consumer consented / opted-in such that their details can be provided to Third Party Organisations outside Australia.
- The Contributors have a robust and effective Consumer opt-out process from the Consumer and to and from DIGIFISH.
- The Consumer has been informed of the Contributors opt-out process.
- The Contributors have a data breach policy.
- The Contributors consent to the DIGIFISH GROUP PTY LTD Privacy compliance attestation audit.

WE COMPLY WITH THE LAW

DIGIFISH GROUP PTY LTD is bound by the Federal Privacy Act 1988 and the National Privacy Principles (NPPs). We follow strict procedures for the storage and disclosure of information which Contributors give us to prevent unauthorised access and comply with all in country legislation.

WHAT PERSONAL INFORMATION DOES DIGIFISH HOLD?

The type of personal information that DIGIFISH holds includes (but is not limited to) personal information about:

- Consumers Direct title, name, date of birth, gender
- Consumers Contact Details address, landline, mobile, email
- Consumer Preferences opted in preferences declared by Consumers
- Mobile Device opted in device movement data
- Address level Consumer attributes such as home valuation etc.

HOW DIGIFISH MIGHT USE AND DISCLOSE CONSUMER PERSONAL INFORMATION?

DIGIFISH may only use Consumer personal information as agreed to by the Consumer with the DIGIFISH Contributors at the point of its collection.

This includes the following purposes depending on the Consumer opt-in status:

- To send you directly or via promoters, customers, and affiliates (together, our partners), who may also share your information with their service providers and partners (together, their partners), advertising information, offers and promotions about products and services based on your preferences and any surveys, offers or prize notifications (Offers) by offline mail, phone/SMS/MMS, or email and online.
- To enable brands and advertisers you select to communicate with you.
- To create insights, directing and addressing campaigns, validating, modelling, data matching and aggregating information with other information obtained from other sources and parties.
- The provision of services and making offers otherwise related to the provision, sending, delivery targeting and facilitating advertising, promotional and direct marketing campaigns to you.
- Appending the information to databases for the purposes of linkage and profiling for digital marketing and campaign purposes.
- Linkage of data, files, records and other information, platforms delivery channels to other data, files, records and information, platforms delivery channels.
- To administer our database of personal information including improving and personalising offers, verifying, and assessing your identity, maintaining, and updating records, developing new products and services.
- To provide information to third parties to enable them to give you offers and additional information.

- We may from time to time need to disclose certain information, which may include your personal information, to comply with a legal requirement, such as a law, regulation, court order, subpoena, warrant, during a legal proceeding or in response to a law enforcement agency request.

MANAGEMENT AND SECURITY OF PERSONAL INFORMATION

DIGIFISH GROUP PTY LTD takes reasonable steps to keep your personal information secure. DIGIFISH maintains physical security over paper and electronic data storage. Personal information about Consumers is stored on servers that sit behind a firewall and is physically housed within a secure data centre.
